1. A non-refundable deposit of \$400 is to be paid to hold the date for the videographer(s).
2. Remaining balance is due at the time of the wedding ceremony. No videos will be distributed until full payment is received. Personal checks are accepted. A 5% monthly fee of balance will be applied to payment if payment, in full, is not received by wedding day. Fees and interest will apply for any returned checks, then only cashiers' check or money order will be accepted.
3. Video picture slideshow will be ready approximately six weeks after receiving pictures/songs to be included in video.
4. If Vaughter Weddings is unable to perform to the guide lines of this contract due to a fire, or other casualty, strike, act of God, act of terrorism, or other cause beyond the control of the parties, or if due to a Vaughter Weddings illness, then all fees paid by the client will be returned in full, but Vaughter Weddings shall have no further liability with respect to the agreement. If Vaughter Weddings is unable to perform to the obligations in this contract for any other reason, Vaughter Weddings will not be liable for cost in excess of the amount the client has paid. This limitation of liability will also apply in the event that footage is lost through camera malfunction, damaged in processing, lost in mail, or otherwise damaged or lost without fault of the videographer or Vaughter Weddings.
5. Prices are subject to change without notice until both parties sign the contract. Only current contracts will be accepted.
6. All rights to videos and photography created by Vaughter Weddings will remain with Vaughter Weddings. Vaughter Weddings reserves the right to display any videos or photos made in conjunction with this wedding as samples of their work for the purposes of window and showroom exhibit, advertising, promotion on the internet, publication, instruction and professional competition. All video and photos will remain a ©Copyright of Vaughter Weddings. Permission for reproduction is granted for personal use. Permission is not granted for commercial use of video or photos for profit. Commercial use of video and photo remains completely at the discretion of Vaughter Weddings.
7. Vaughter Weddings is granted full production and editorial control regarding all aspects of the production and post-production services for this event.
8. Wedding videos will be kept on file for one month after completion. After one month, changes will not be able to be made.
9. Our DVDs are playable on most standard DVD players, and computer DVD-ROM drives. Your DVD player should play DVD-R to be fully compatible. Please ask for more information.
10. Seat(s) at the reception, for dinner, are required for videographer(s).
11. We cannot guarantee the operation of the wireless microphone at the ceremony. We use high quality UHF microphones, but cannot be responsible if we are unable to get good recordings of the wireless microphone do to interference. We will, however, still have the audio recording from the on-camera microphone.
12. Travel fees, airfare, and/or hotel accommodations, if applicable, are additional for out of state weddings.
